

NETTALK VOICELINE INC. INDEPENDENT AGENT AGREEMENT

1. This Agreement is between Nettalk Voiceline Inc. and _____,

An independent agent who has chosen to market long distance service as an independent contractor of Nettalk Voiceline Inc (NTVL).

2. NTVL is engaged in providing long distance calling plans and other telecommunication services to individuals and businesses in the 48 contiguous United States and internationally. Independent agent agrees to market these programs as an exclusive agent of NTVL.

Agent agrees not to make any attempt to circumvent these relationships in any way that would bring harm, damages, or financial losses to NTVL.

Agent does not necessarily have to have a personal calling plan account with NTVL

3. NTVL agrees to compensate an **affiliate agent** on a commission basis only. Affiliate agent is paid a commission on the monthly subscription paid by the service accounts plus a dollar amount on the one time activation fee on all new accounts referred to NTVL by the independent agent.

NTVL agrees to compensate a **Referral agent** a dollar amount of US\$10.00 on each activated referral to NTVL.

4. Independent agent must earn commissions of at least \$10.00 in order to receive a monthly check. Any monthly commissions less than \$10.00 will be carried forward for one month or added to the agent's personal account with NTVL if any exist. Initial checks usually begin 30-60 days from the provisioning of the initial customer(s).

Independent agent must maintain at least one customer signup per month in order to maintain agent status. If after 3 months of inactivity NTVL reserve the sole discretion to terminate the agent agree.

NTVL will make payment by check, PayPal or bank lodgment if the commission is 25.00 or more.

5. All expenses that agent may incur in connection with acquiring customers are the responsibility of the independent agent. NTVL will issue a 1099 tax statement for all US agents who earn in excess of \$600.00 a year in income.

6. NTVL may cancel this agreement at any time if independent agent is found to be guilty of "slamming" a customer's long distance service. Agent will not be given the customer's NTVL account information except Name and contact information. NTVL will be held harmless from any loss, cost, damage, expense or liability that occurs due to independent agent's violation of this clause in the agreement.

7. This agreement and all questions as to its interpretation, performance, enforcement and the rights and remedies of the concerned parties are governed by the laws of the State of Florida and is binding on both parties. The parties agree that any legal action arising from this agreement and relationship shall be submitted to a Florida arbitrator in the state of Florida.

8. This agreement will endure for a period of 1 year, subject to an automatic renewal. Your residual income in NTVL may NOT be passed on to any family members or heirs.

NTVL reserves the rights to alter this agreement from time to time.

9. All print and media-related advertising or interviews must be pre-approved by NTVL. Agent agrees not to interfere with NTVL's current advertising efforts by competing in the same existing publications unless otherwise consented to by NTVL.
